COVID-19 Vaccine Consumables

The Commonwealth's current consumable supply of 0.9% Sodium Chloride 10mL Ampoules will expire on <u>31 October 2024</u>. The 0.9% Sodium Chloride 10mL Ampoules are used for the dilution of the **Pfizer (XBB.1.5) 6 months-4 years (Maroon)** vaccine. The last order window for this stock will close on **11 October 2024**.

In line with harmonising access to COVID-19 vaccines with other vaccine programs, such as the National Immunisation Program, the Commonwealth **will no longer supply** 0.9% Sodium Chloride 10mL Ampoules under the COVID-19 vaccination program after **11 October 2024.**

Primary Care sites will be required to source 0.9% Sodium Chloride 10mL Ampoules separately to be able to dilute the Pfizer (XBB.1.5) 6 month- 4 years (Maroon) vaccine.

Any Sodium Chloride 0.9% Solution used, <u>should be Australian Register of Therapeutic</u> <u>Goods (ARTG)</u> listed. **No other dilutant** including Bacteriostatic 0.9% Sodium Chloride should be used.

Reminder of COVID-19 Vaccine Stock Management

It is important that all participating sites manage your vaccine stock. While we encourage sites to reduce any wastage of COVID-19 Vaccines, we understand that this is not always possible, due to multi-dose vials and decreased demand.

The COVID-19 Vaccine Administrative System (CVAS) has existing vaccine wastage and stock control measures in place to support your site in mitigating wastage and to ensure the Commonwealth's vaccine stock is being managed appropriately.

From 1 October 2024, **it is now mandatory to provide a reason** for requiring the requested doses (e.g. preparing for a target clinic) if you receive a warning for risk of wastage and/or holding excessive stock.

This warning will not affect your site placing the order, however the Department may contact you to discuss your order and options to minimise wastage and/or holding excess vaccine stock.

Participating sites can manage vaccine stock by:

- skipping orders and only ordering when you need to (you do not need to order every fortnight); and/or
- ordering less than your maximum allocation, and/or
- transferring excess stock in line with the COVID-19 Vaccine Transfer Policy.
